



Dear Valued Accuride Partner:

Thank you for choosing Accuride as your wheel or wheel-ends supplier. We are writing to inform you that Accuride and its U.S. affiliates have reached an agreement with their lenders to restructure the North American business. Accordingly, on October 9, 2024, Accuride Corporation and certain of its U.S. subsidiaries (including Gunite Corporation and KIC, LLC), and its Canadian subsidiary (collectively, “Accuride”) announced that we have voluntarily filed a petition under Chapter 11 of the U.S. Bankruptcy Code and commenced a proceeding under the Companies’ Creditors Arrangement Act (“CCAA”) in Canada.

Accuride has \$30 million in Debtor-in-Possession financing, which is structured to provide sufficient liquidity to continue normal operations and meet post-petition obligations to employees, suppliers and customers as they come due. Accuride and its subsidiaries intend to continue operations and serve customers as usual.

Accuride has filed customary first-day motions with the Bankruptcy Court to support operations during the court-supervised process, including motions requesting authority to continue to honor customer contracts and programs. Both Accuride and our customers are bound by the current terms and conditions.

Our Mexican, European, and Asian subsidiaries are not part of the filing and will not be subject to the Chapter 11 and CCAA processes.

We are committed to the relationships we have developed with our customers and will continue to work closely with you throughout this process.
